The Commission is correcting its *Order Setting Procedural Schedule*, issued March 7, 2025, nunc pro tunc pursuant to Commission Rule 20 CSR 4240-2.160(4) to accurately reflect the intended calculation of days to respond to data requests after April 22, 2025.

On March 27, 2025, the Office of the Public Counsel filed a motion for clarification of the Commission's *Order Setting Procedural Schedule*. Public Counsel notes that the order provides for both "5 business days" and "five (5) calendar days" to respond to data requests after April 22, 2025.
