WEATHER NORMALIZATION ADJUSTMENT RIDER (WNAR)

APPLICABILITY

The Weather Normalization Adjustment Rider (WNAR or Rider) is applicable to all Ccf of gas delivered to all customers served under Company's Residential Service classification. The Rider will be applied as a separate line item on the customer's bill.

FILING

The Company shall make a WNAR filing each calendar year to be effective for the November billing month. The filing shall be made at least sixty (60) days prior to the effective date.

WEATHER NORMALIZATION ADJUSTMENT CALCULATION

$WA = \frac{AWNA + AR + OA + AD}{Expected recovery period Residential billed usage}$

- WA = Weather adjustment rate to be applied to the Residential service class usage over the recovery period.
- AWNA = Annual WNA is the sum of the Monthly WNA for the billing months in the twelve (12) month period ended each July.
- AR = Annual reconciliation of the calculated Monthly WNA to the actual dollars collected for the sum of the last three (3) billing months of the recovery period related to the prior recovery period and the first nine (9) billing months of the recovery period related to the current recovery period.
- OA = Ordered Adjustment is the amount of any adjustment to the WNA
 ordered by the Commission as a result of corrections under
 this Rider. Such amounts shall include monthly interest at
 the Company's monthly short-term borrowing rate.

The recovery period is the twelve (12) billing months of November through October.

There shall be a limit of \$0.05 per Ccf on upward adjustments of the WA, and no limit on downward adjustments. Any amount not recovered due to this limitation of WA to no more than \$0.05 per Ccf will be deferred for recovery from customers in the next recovery period.

WEATHER NORMALIZATION ADJUSTMENT RIDER (WNAR)

APPLICABILITY

The Weather Normalization Adjustment Rider (WNAR or Rider) is applicable to all Ccf of gas delivered to all customers served under Company's Residential <u>sS</u>ervice classification. The Rider will be applied as a separate line item on the customer's bill.

FILING

The Company shall make a WNAR filing each calendar year to be effective for the November billing month. The filing shall be made at least sixty (60) days prior to the effective date.

AWNA") = <u>Annual WNA is</u> the sum of the Monthly WNA for the billing months in the twelve (12) month period ended each July.

- AR _____ = Annual reconciliation of the calculated Monthly WNA to the actual dollars collected for the sum of Prior to the end of the twelve months of billing of each AWNA, the over- or under-billing of the AWNA shall be calculated based on twelve months of actual sales, consisting of the last three (3) billing months of the recovery period related to the prior recovery period and the first nine (9) billing months of the recovery period related to the currently effective AWNA recovery period.
- OA = Ordered Adjustment is the amount of any adjustment to the WNA ordered by the Commission as a result of corrections under this Rider. Such amounts shall include monthly interest at the Company's monthly short-term borrowing rate.

The recovery period is the twelve (12) billing months of November through October.

There shall be a limit of \$0.05 per Ccf on upward adjustments of the WA, and no limit on downward adjustments. Any amount not recovered due to this limitation of WA to no more than \$0.05 per Ccf will be deferred for recovery from customers in the next recovery period.
