On February 19, 2025, White River Valley Electric Cooperative, Inc. (White River) filed an Application for Approval of Designated Service Boundaries within Christian County, Missouri pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045. On February 27, 2025, Staff was ordered to file a Recommendation by March 28, 2025.

On March 26, 2025, Staff filed a Status Report saying they would not file a recommendation until April 21, 2025. On March 27, 2025 all parties were ordered to file a Procedural Schedule by April 3, 2025.

On April 3, 2025, Staff filed a pleading titled "Motion for Extension" and requested additional time to file a Procedural Schedule. Staff stated no other party objected to the extension and stated they would file a Procedural Schedule by April 8, 2025.

The Commission will order Staff and Parties to file a Procedural Schedule no later than April 8, 2025.

THE COMMISSION ORDERS THAT:

1. Staff shall file a Procedural Schedule no later than April 8, 2025.
2. This order is effective when issued.
