## ORDER OF CORRECTION

Issue Date: April 7, 2025

Effective Date: April 7, 2025

The Commission is correcting its *Order Dismissing Complaint*, issued March 12, 2025, nunc pro tunc under Commission Rule 20 CSR 4240-2.160(4), to correct the issue, effective and closing file dates.

The issue date incorrectly states: "March 5, 2025". It is hereby corrected to read: "March 12, 2025". The effective date incorrectly states: "April 4, 2025". It is hereby corrected to read: "April 11, 2025".

Body paragraph eleven incorrectly states: "Under Commission Rule 20 CSR 4240-2.070(14), the regulatory law judge shall cause the parties to be notified that the Commission's decision will be final unless an application for rehearing is filed. The application for rehearing must be filed with the Commission before the effective date of this order, which is April 4, 2025.<sup>3</sup> If the Commission denies the application for rehearing, the parties then have 30 days after the denial is issued to file an appeal with the court of appeals.<sup>4</sup> If the Commission grants the application for rehearing, then the Commission will order appropriate actions at that time." It is hereby corrected to read:

“Under Commission Rule 20 CSR 4240-2.070(14), the regulatory law judge shall cause the parties to be notified that the Commission’s decision will be final unless an application for rehearing is filed. The application for rehearing must be filed with the Commission before the effective date of this order, which is April 11, 2025.<sup>3</sup> If the Commission denies the application for rehearing, the parties then have 30 days after the denial is issued to file an appeal with the court of appeals.<sup>4</sup> If the Commission grants the application for rehearing, then the Commission will order appropriate actions at that time.”

Ordered paragraph two incorrectly states: “If any party wishes to request a rehearing by the Commission, such request must be filed no later than April 3, 2025.” It is corrected to read: “If any party wishes to request a rehearing by the Commission, such request must be filed no later than April 10, 2025.”

Ordered paragraph three incorrectly states: “This order shall become effective on April 4, 2025.” It is corrected to read: “This order shall become effective on April 11, 2025.”

Ordered paragraph four incorrectly states: “This file shall be closed on April 5, 2025.” It is corrected to read: “This file shall be closed on April 12, 2025.”

1. The Commission’s *Order Dismissing Complaint*, issued March 12, 2025, is corrected nunc pro tunc, as set forth in the body of this order.
