## **ORDER APPROVING REQUEST TO APPROVE TECHNICAL RESOURCE MANUAL AND DEEMED SAVINGS TABLE**

Issue Date: April 9, 2025

Effective Date: April 19, 2025

On January 30, 2025, Union Electric Company d/b/a Ameren Missouri filed a *Request to Approve Technical Resource Manual and Deemed Savings Table and Motion for Expedited Treatment* (Motion). Ameren Missouri explains that it filed a similar motion on November 27, 2024, which the Commission approved on December 11, 2024. Ameren Missouri then asked for clarification of the December 11, 2024 order, which the Commission granted on January 15, 2025.

Ameren Missouri has now updated its Technical Resource Manual (TRM) and Deemed Savings Table to reflect the measures as modified by the Commission's January 15, 2025 order. Ameren Missouri states that it consulted with the Commission's Staff (Staff), and that Staff had no concerns.

Parties have ten days to respond to pleadings unless otherwise ordered by the Commission.<sup>1</sup> More than ten days have elapsed since Ameren Missouri filed its Motion, the Commission issued no order contrary to the rule, and no party has responded to Ameren Missouri's Motion. Thus, the Commission will take up the Motion unopposed.
