**ORDER DIRECTING NOTICE AND SETTING DEADLINE FOR
RESPONSES**

The United Way of Greater St. Louis, Inc. (UWGSL) filed its *Reapplication for 2-1-1 Authority* on January 6, 2017. The Commission issued an order directing the Staff of the Missouri Public Service Commission to file a list of entities it recommends receive notice of UWGSL's Reapplication. Staff submitted its recommendation on February 9, 2017. Staff also filed its *Staff Recommendation* that the Commission approve the Reapplication and allow UWGSL to provide the abbreviated dialing service that offers local callers pertinent information and refers them to appropriate human service providers.

The Commission will issue notice to the persons and entities recommended by Staff. The Commission will also set a deadline for filing any interventions and for filing responses to Staff's Recommendation to approve the Reapplication.

THE COMMISSION ORDERS THAT:

1. The Data Center of the Commission shall provide notice to the entities listed in Attachment A of Staff's February 9, 2017 filing and the County Commissions for

the counties listed in paragraph 31 of the January 6, 2017 *Reapplication for 2-1-1 Authority*.

2. The Public Policy and Outreach Department of the Commission shall provide notice of the application to the members of the General Assembly representing residents of the counties and to news media serving residents of the counties listed in paragraph 31 of the January 6, 2017 *Reapplication for 2-1-1 Authority*.

3. Any entity wishing to intervene in this matter shall do so no later than March 3, 2017.

4. Responses to the January 27, 2017 Staff Recommendation may be filed no later than March 10, 2017.

5. This order shall be effective when issued.




