On April 7, 2025, the Staff of the Commission (Staff) filed a *Staff's Request for Additional Time to File Recommendation*. The Commission had previously directed Staff to file a recommendation regarding this application no later than April 7, 2025.

The Request sought an extension of time for the filing of Staff's recommendation to May 7, 2025. The Request stated that responses to data requests were received, but Staff will need additional time to properly analyze the data requests as well as determine if further data requests are necessary to be submitted. The Commission finds the Request reasonable and will grant it.
