ORDER DIRECTING RESPONSE

Issue Date: April 10, 2025

Effective Date: April 10, 2025

The signatories filed two stipulation and agreements (Agreements) as a resolution of this electric rate case. Seven days have passed without objection and the Commission may treat the Agreements as unanimous.¹ As an alternative to an on-the-record presentation where the Commission would ask questions of the parties, the Commission will instead ask the signatories to answer a few specific questions, so the Commission may make an informed decision about whether to approve the Agreements.

The Commission understands that portions of the Agreements are a “black box settlement” and the Commission is not trying to infringe upon the parties’ settlement negotiations.² However, the Commission finds that additional data would assist the Commission in evaluating the Agreements and ensuring they represent a reasonable resolution of this case. The Commission understands that answers may be different for different parties and multiple answers to a question may be required. If the signatories will not answer a question, please provide the Commission with a reason.

The Commission will ask the signatories to answer the following questions:

1. What is the total revenue requirement? Is the revenue requirement contained in testimony or schedules? If so, where?
2. Is the revenue requirement reflected in the table attached to the March 20, 2025, *Stipulation and Agreement*?
3. Why do the rates contained in Exhibit A to the March 20, 2025, *Stipulation and Agreement* not result in a \$355 million increase when compared to similar information contained in Exhibit A to the Stipulation and Agreement approved in the Commission's Report and Order issued June 14, 2023, in File No. ER-2022-0337?

The Commission would prefer, but will not require, that the signatories answer the following additional questions:

4. What is the cost of capital, if different from 7 percent weighted average cost of capital contained in the March 14, 2025, *Stipulation and Agreement*?
5. What is the rate of return?
6. What is the return on equity?

The Commission will ask the Agreements' signatories to file a joint answer to the above questions. If the parties desire, the Commission will treat the answers as confidential and they may be filed with an appropriate confidential designation (C or HC).

THE COMMISSION ORDERS THAT:

1. No later than April 14, 2025, at noon the Agreements' signatories shall file an answer to the Commission's questions.

2. This order is effective when issued.
