## ORDER DIRECTING FILING

White River Valley Cooperative, Inc.(White River) filed an application on February 19, 2025 pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045, for an Order Approving Designated Service Boundaries. On March 27, 2025, all parties were ordered to file a Procedural Schedule by April 3, 2025. On April 3, 2025 Staff filed a pleading titled “Motion for Extension” and requested additional time to file a Procedural Schedule. Staff stated no other party objected to the extension and stated they would file a Procedural Schedule by April 8, 2025.

On April 8, 2025 Staff Counsel filled a Second Motion for Extension. On April 9, 2024, an Order was issued by the Commission to hold a Pre-Hearing Conference on April 10, 2025. On April 10, 2025 a Pre-Hearing Conference was held with Counsel for Empire, Staff Counsel, and White River participating. After discussion and by agreement, all parties are ordered to submit a Procedural Schedule to the Commission no later than Monday, April 14, 2025.

The Commission will order the Procedural Schedules to be filed no later than April 14, 2025.

1. Proposed Procedural Schedules are to be filed by all parties no later than April 14, 2025.
2. This order shall be effective when issued.
