## ORDER RECOGNIZING NAME CHANGE AND NOTICE THAT TARIFFS WILL GO INTO EFFECT BY OPERATION OF LAW

Issue Date: April 11, 2025

Effective Date: April 18, 2025

On March 24, 2025,<sup>1</sup> Consolidated Communications Enterprise Services, Inc. requested that the Commission recognize its name change to Consolidated Communications Enterprise Services, LLC, and approve its adoption tariff sheets. The adoption tariff sheets were assigned Tracking Nos. JC-2025-0136, JC-2025-0137, JX-2025-0138, JX-2025-0139, and JC-2025-0140. The submitted tariffs sheets all have an effective date of April 18, 2025.

On April 3, the Staff of the Commission (Staff) filed a notice that Consolidated Communications failed to submit a proper adoption notice and revised title sheet for its Missouri P.S.C. Tariff No. 6. The Commission order a response from Consolidated Communication. On April 8, Consolidated Communications filed its request to cancel its Missouri P.S.C. Tariff No. 6, explaining that the tariff is associated with assets that have been sold to a different local exchange carrier, and thus the tariff is no longer needed by

Consolidated Communications. Missouri P.S.C. Tariff No. 6 was cancelled by the Commission on April 9.

The Commission finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change.
