



Next I got a call from SPIRE on Jan. 30 saying they would come out and install the digital one. Opting out would cost \$ mouther would cost \$ mouther would cost and the cost of gas consumption. This is EXTORTION.

Decades ago, readers were sent out every 6+ months to physically verify readings people MAILED IN monthly. I can certainly read it and send you the readings. And you **could come quarterly**, for example, thereby reducing your manpower requirement, and saving the customer **\$100**/yr, instead of charging the exorbitant and unfair fee of **\$100**/yr..., which most people can't afford! We are already looking at rate increases by Ameren, probably to pay for their smart meters which last only 6-8 yrs compared to 20-40 yrs for the old analogs... This will cost them **\$100**/000 in MO to replace the first round of installed digital meters...(and over and over again in time?).... Total inefficiency, ineptitude and disgraceful gouging of customer's resources.

I am a founding member of **St. Louis for Safe Technology**. We have a followship of about 400 people. We are ALL opposed to these digital meters and the way the rollouts have been handled. One of our members and top contributors is **ROBERT WORKMAN**, Certified Building Biology Environmental Consultant and EM Radiation Specialist has been coaching people concerned, and helping provide solutions to mitigate radiation exposure, when possible. Below is a video he did with **BILL BATHGATE**, Electrical Engineer and Building Biology instructor, who has ample experience with these meters. THEY ARE NOT GOOD FOR US.



Voltage Gated Calcium Channels (VGCC)<sup>21</sup>

Dr. Martin Pall, PhD, Washington State University School of Molecular Biosciences, has taken the lead to explain VGCC. Substantial literature shows all EMI's activate the VGCC in the cell membrane and increase intercellular calcium (Ca<sup>2+</sup>) ions.




Figure 28 Voltage Gated Calcium Channels

Increased intracellular Ca<sup>\*</sup> can act to stimulate nitric oxide (NO) synthesis; such NO increases also have an important role in biology & medicine. Arthur A. Pilla (2012), researcher, showed that such low-intensity pulsed microwave exposures produce increases in both Ca<sup>2+</sup> and NO synthesis in less than 5 seconds.

VGCCs have been shown to have a universal or near universal role in converting electrical effects into chemical changes in the cell. Note: *NO is an important cellular signaling molecule. It helps modulate vascular tone, insulin secretion, airway tone, and peristalsis, and is involved in angiogenesis and neural development. It may function as a retrograde neurotransmitter.* 

Pulsed EMF's are much more bio-active than non-pulsed fields this has been known for 30 years. A series of studies show EHS effects can be blocked by calcium channel blockers. There are 100's of studies that show low intensity microwave exposures are followed by changes in calcium fluxes and/or by changes in calcium signaling. Also, there are 100's of studies showing low-intensity microwave radiation produces oxidative stress responses due to downstream effects of VGCC activation. *There can be no question that VGCCs are the major, perhaps the only targets of low intensity EMF's in the body.* Strong support for cell level effects from HF and other human-made EMFs. VGCCs have physical properties which predict that

### Non-Thermal Effects

Scientists from all over the world keep observing non-thermal effects, which are quite alarming. Electromagnetic waves exert forces on charged particles of matter: electric charges are changed in their sphere of influence; molecules and ions follow the orientation of the constantly alternating field. Microwave radiation, for example, is capable of exciting rotation or vibration in heavily polarized water molecules, converting radiation into heat along the way. It also seems to be more than likely that sensitive hydrogen bonds in cells and membranes are affected. These are some of the pathways through which radio frequency radiation can be taken in or absorbed by the body.

In 1996, Dr. Henry Lai found enormous increase in double-stranded DNA breaks in rat brain tissue only after 2 hours cell phone microwave exposure. A Swedish group at Lundt University studied the effect of 915 MHz EMR on the blood brain barrier (BBB) in rats. Cellular phones use frequencies from 824 to 894 MHz. The BBB restricts the movement of medium and large size molecules from the blood to cerebrospinal fluid (EMR Health, 1995). Figure 14.

The introduction of smart meter AMI technology is relatively new and little research has been conducted. However, anecdotal and observational studies are showing that people who were not medically affected by other wireless technology suddenly or within months of smart meter installation display a host of symptoms: headache, heart arrhythmia, dizziness, nausea, memory loss, muscle spasms, inflammation, breathing


problems, weakness, insomnia, seizures. From early information it appears that up to 18% of the population is being affected with 3% affected immediately and the remainder after several months of exposure.

Research conducted in Switzerland and reported by Dr. Dietrich Klinghardt, MD in 2011 took mold cultures and initially shielded them from ambient laboratory EMR using RF shielding cloth, effectively creating a faraday cage. When the cloth was removed the mold cultures were exposed to the ambient EMR in the lab from the lights, computers and nearby cell phone tower. Under this new influence the molds produced more than 600 times the quantity of biotoxins than they produced when shielded from EMR. And the biotoxins weren't simply more plentiful, they were also more potent and virulent. This finding could explain many things – from the rise of 'superbugs' sweeping through entire hospital wards (hospitals are bristling with cell towers, Wi-Fi and EMR in general), to the reason that some people are far more sensitive to EMR than others. The sensitive people may well have an underlying Candida infection or other microbial infection that is flooding their bodies with biotoxins in response to the exposure to wireless emissions and other sources of EMR.




