ORDER TO SHOW CAUSE

Issue Date: April 14, 2025

Effective Date: April 14, 2025

On December 31, 2024, Ramey Chisum filed a complaint before the Missouri Public Service Commission (Commission). An Order was issued on March 25, 2025 directing that a prehearing conference be held for the parties. A prehearing conference was held on April 14, 2025 and the Complainant did not appear, nor did the Complainant notify the Commission of a reason for not attending. The prehearing conference was attended by Staff Counsel and Counsel for Evergy. Non-attendance at the prehearing conference is grounds for dismissal under 20 CSR 4240-2.110. In this instance the Complainant failed to seek a continuance and did not appear. In order to prevent dismissal of this complaint, the Complainant must file pleadings showing why this application should not be dismissed.

This order directs the Complainant to show cause why they did not appear before April 21, 2025.

THE COMMISSION ORDERS THAT:

1. The Complainant shall file pleadings that show why this application should not be dismissed by April 21, 2025.
2. This order shall be effective when issued.
