### ORDER DIRECTING FILING

Issue Date: April 15, 2025 Effective Date: April 15, 2025 On February 27, 2025, Vicinity Energy Kansas City, Inc. (Vicinity) filed a tariff sheet to adjust its Production Adjustment Cost Clause (PACC). The tariff had an effective date of June 1, 2025.

Vicinity filed substitute tariff sheets on March 6, March 10, March 31, April 1, and April 11, 2025. The April 11, 2025 substitute tariff sheet bears an effective date of May 1, 2025.

The Staff of the Commission filed its Recommendation and Motion for Expedited Treatment on April 14, 2025. Staff stated that Vicinity's PACC tariff required Vicinity to file its PACC tariff by February 1. Vicinity's late filing of its tariff and its subsequent substitute tariff sheets prevented Staff from filing its Recommendation by April 1, also as required under Vicinity's tariff. Staff recommends the Commission approve the PACC tariff sheets, and further asks for expedited treatment so that the sheets may become effective on May 1, 2025.

The Commission will allow time for responses.

#### THE COMMISSION ORDERS THAT:

1. Any responses to Staff's Recommendation shall be filed no later than April 18, 2025.

2. This order is effective when issued.
