### STAFF RECOMMENDATION TO APPROVE PROPOSED REVISED TARIFF SHEET

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Proposed Revised Tariff Sheet* in response to the Commission's April 2, 2025, *Order Directing Staff Recommendation on Compliance Tariff Sheets* (*Order*), and states as follows:

1. On March 12, 2025, Staff and Spire Missouri, Inc. d/b/a Spire ("Spire"), filed a Full and Unanimous Stipulation and Agreement with the Commission.

2. On March 26, 2025, the Commission issued an Order Approving the Stipulation and Agreement and Establishing Ending ACA Balance, which also required Spire to submit a revised tariff with the Commission.

3. On April 2, 2025, Spire filed a revised tariff sheet that includes the Commission approved line of credit fee language. The revised tariff sheet had an effective date of May 2, 2025, and was assigned Tracking Number JG-2025-0143.

4. On April 2, 2025, the Commission ordered Staff to file a recommendation regarding said tariff sheet no later than April 16, 2025.

5. Staff has reviewed the tariff sheet filed on April 2, 2025, with an issue date of April 2, 2025, and an effective date of May 2, 2025, and assigned Tracking No. JG-2025-0143, and recommends the Commission approve or allow to go into effect for service as follows:
