## ORDER DIRECTING COMPLAINANT TO EXPLAIN VIOLATION

Issue Date: April 16, 2025 Effective Date: April 16, 2025

On April 14, 2025, Catherine Cogorno, Complainant, filed a complaint with the Commission against Spire Missouri Inc. d/b/a Spire. In her complaint, Complainant states that she does not want to pay \$30 per month for an Advanced Metering Infrastructure (AMI) meter. The Commission's formal complaint form asks complainants to state the statute, tariff, or Commission regulation or order that Spire violated. Complainant's formal complaint form states: "No violation. Just a request..."

Section 386.390 RSMo, provides that a person may file a complaint against a utility, regulated by this Commission, setting forth any act or thing done or omitted to be done by any corporation, person or public utility in violation, or claimed to be in violation, of any provision of law subject to the Commission's authority, of any rule promulgated by the Commission, of any utility tariff, or of any order or decision of the Commission.

Complainant has not alleged a violation recognized under the complaint statute. Before proceeding further with this complaint, the Commission will direct Complainant to explain what Spire's alleged violation.

## THE COMMISSION ORDERS THAT:

- 1. Catherine Cogorno shall file a pleading explaining Spire's alleged violation no later than April 25, 2025.
  - 2. This order is effective when issued.
