ORDER APPROVING COMPLIANCE TARIFF

On April 2, 2025, Spire Missouri Inc. d/b/a Spire filed a tariff sheet, Tracking No. JG-2025-0143, to comply with the Commission's March 26, 2025, *Order Approving Stipulation and Agreement and Establishing Ending ACA Balance*. The tariff sheet bears an effective date of May 2, 2025.
