On April 15, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed its 2024 Annual Renewable Energy Standard Compliance Report (Report) and its 2025 Annual Renewable Energy Standard Compliance Plan (Plan), as required by Commission Rule 20 CSR 4240-20.100(8). Additionally, Evergy Missouri Metro requested a variance from 20 CSR 4240-20.100(8)(A)1.I.(V) regarding the provision of meter readings used in the calculation of payments for renewable energy credits to various renewable energy resource vendors.

Commission Rule 20 CSR 4240-20.100(8)(D) requires the Staff of the Commission (Staff) to review renewable energy standard (RES) compliance reports and plans and file a report of its review with the Commission within 45 days of the date of filing.¹ The rule also allows the Office of the Public Counsel and other interested persons or entities to file

comments within the same 45-day period.² Any objection to the request for a variance shall also be filed by the same date.

The Commission will direct that notice of this filing be given as required by Commission Rule 20 CSR 4240-20.100(8)(C).

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to each party to Evergy Missouri Metro's most recent general rate case, File No. ER-2022-0129.

2. The Commission's Data Center shall provide notice of this order to the county commission of each county within Evergy Missouri Metro's service area.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the news media serving residents of the counties within Evergy Missouri Metro's service area.

4. Staff shall review the RES compliance report and plan and file a report no later than May 30, 2025.

5. Any comments on the RES compliance report and plan shall be filed no later than May 30, 2025.

6. Any objection to the request for a variance shall be filed no later than May 30, 2025.

7. This order shall be effective when issued.
