ORDER DIRECTING FILING

On April 17, 2025, the Staff of the Commission (Staff) filed a *Staff's Status Report* (Report). The Commission had previously directed Staff to file a recommendation regarding this joint application no later than April 18, 2025.

The Report indicated that the application filed by The Empire District Electric Company d/b/a Liberty and Ozark Electric Cooperative (collectively, "Joint Applicants") had a deficiency by not including an adequate map delineating the boundary lines for the Joint Applicants. The Commission will direct the Joint Applicants to file adequate maps or a statement of the reasons the information is currently unavailable and a date by which it will be furnished as required under 20 CSR 4240-3.130.

THE COMMISSION ORDERS THAT:

1. Not later than April 30, 2025, the Joint Applicants shall file a map delineating the boundary lines for Liberty and Ozark Electric Cooperative or a statement of the reasons the information is currently unavailable and a date by which it will be furnished.
2. All other actions in this matter shall cease and all time limitations and deadlines are tolled until further order of the Commission.

3. This order shall be effective when issued.
