## ORDER SHORTENING TIME FOR RESPONSES

Issue Date: April 22, 2025

Effective Date: April 22, 2025

On April 3, 2025, Summit Natural Gas of Missouri Inc. (SNGMO) filed an application and tariff sheets to extend its Equipment Rebate Program (ERP) Pilot to December 31, 2027. The tariff sheets bear an effective date of May 3, 2025.

On April 22, 2025, the Staff of the Commission (Staff) filed its recommendation. Staff recommended that the Commission reject SNGMO's application, order SNGMO to cease issuing ERP rebates, and to order SNGMO to submit an application for a general rate case.

The Commission will shorten the timeline for responses due to the pending effective date of the tariff sheets.

### THE COMMISSION ORDERS THAT:

1. Responses to Staff's recommendation shall be filed no later than April 28, 2025.
2. This order shall be effective when issued.
