## ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

Issue Date: April 23, 2025

Effective Date: April 23, 2025

On April 1, 2025, Joe Wissman filed a complaint with the Commission against Ameren Transmission Company of Illinois (ATXI). On April 2, 2025, the Commission issued its *Order Giving Notice of Case Filing, Directing an Answer, Directing Complainant to Supplement His Complaint, and Directing a Staff Investigation*, which also explained how to request mediation. Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate, if mediation is unsuccessful the case returns to the contested case track. No party relinquishes any rights by agreeing to participate in mediation. ATXI filed a request for mediation on April 21, 2025.

The Commission will direct Joe Wissman to state whether he agrees to mediation of the formal complaint.

### THE COMMISSION ORDERS THAT:

1. No later than May 1, 2025, Joe Wissman shall respond to ATXI's mediation request and state whether he agrees to enter into mediation.
2. All procedural deadlines are stayed until the Commission rules on ATXI's mediation request.

3. This order is effective when issued.
