On April 3, 2025,¹ Summit Natural Gas of Missouri Inc. (SNGMO) filed an application and tariff sheets to extend its Equipment Rebate Program (ERP) Pilot to December 31, 2027. The tariff sheets bear an effective date of May 3, 2025.

On April 22, the Staff of the Commission (Staff) filed its recommendation. The Commission shortened the time for responses to Staff's recommendation due to the pending effective date of the tariff sheets.

On April 25, SNGMO timely filed a *Motion for Extension* (Motion). The Motion requested an extension until June 2 for SNGMO to file its response to Staff's recommendation. The Motion indicated that Staff had no objection to the extension. The Motion also noted that SNGMO voluntarily extended the effective date of its tariff sheets to June 7.

The Commission finds the requested extension reasonable, and will grant it. The extension will apply to all parties wishing to file a response to the Staff recommendation.
