ORDER GRANTING MOTION TO ESTABLISH A CASE

On April 23, 2025 the Staff of the Missouri Public Service Commission (Staff) by and through counsel, and for its Motion to Establish a Case, states that pursuant to Section 386.020 of the Revised Statutes of Missouri (RSMo) the Commission has jurisdiction over Spire Missouri, Inc. d/b/a Spire (Spire). Staff states that on Tuesday, April 22, 2025, a reportable gas incident occurred in the 9500 block of Grandview Road in Kansas City, Missouri, an area serviced by Spire, when a third-party excavator damaged a high pressure 10-inch steel gas main. Spire personnel responded to investigate and repair the damage and reported that a flash fire injured an employee.

Staff states that a member of the Safety Engineering Department visited the incident location and that Staff intends to investigate and issue a report by September 30, 2025.

The Commission finds that it should establish a case to receive information relevant to the above-described incidents, and to determine what, if any, action the Commission should take. Thus the Commission will establish Case No. GS-2025-0295.

THE COMMISSION ORDERS THAT:

- 1. Case No. GS-2025-0295 is hereby established to receive an incident report from Staff about the natural gas incident that occurred on April 22, 2025, at the 9500 block of Grandview Road in Kansas City, Missouri located in Grandview, Missouri.
 - 2. Staff shall file its final incident report no later than September 30, 2025.
 - 3. This order shall be effective when issued.
