**REQUEST FOR MEDIATION OF COMPLAINT
AND REFERRAL TO NEUTRAL THIRD-PARTY MEDIATOR**

COMES NOW, Ameren Transmission Company of Illinois ("ATXI" or the "Company"), through its undersigned counsel, pursuant to 20 C.S.R. 4240-2.125(2), and for its *Request for Mediation of Complaint and Referral to Neutral Third-Party Mediator*, respectfully states the following to the Missouri Public Service Commission ("Commission"):

1. On April 1, 2025, Joe Wissman ("Complainant" or "Mr. Wissman") filed a formal complaint with the Commission against the Company.
2. On April 2, 2025, the Commission issued its *Order Giving Notice of Case Filing, Directing and Answer, Directing Complainant to Supplement His Complaint, and Order Directing a Staff Investigation*, which provided the Company 30 days to file its answer or, in the alternative, to request the complaint be referred to a neutral third-party mediator for voluntary mediation of the complaint. This filing complies with that Order insofar as it represents a request to initiate the mediation process.
3. ATXI believes this matter is appropriate for mediation and therefore requests the Commission refer this matter to a neutral third-party mediator for mediation between Complainant and the Company, pursuant to 20 C.S.R. 4240-2.0125(2).

4. ATXI notes that pursuant to 20 C.S.R. 4240-2.125(2)(C) the 30-day timeline for the Company to file its answer in this case shall be tolled, pending the Commission's determination as to whether Complainant will participate in good faith in the mediation process or the completion of mediation process thereof.

WHEREFORE, ATXI requests that the Commission accept this *Request for Mediation of Complaint and Referral to Neutral Third-Party Mediator*, thereby initiating the mediation process and tolling the 30-day time period for ATXI to answer the complaint, and for any other relief deemed necessary and appropriate by the Commission.

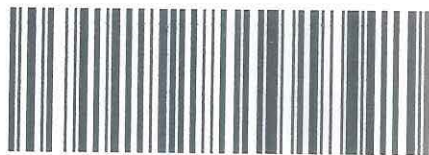
