ORDER DIRECTING RESPONSE REGARDING LOCAL PUBLIC HEARING

Issue Date: April 28, 2025

Effective Date: April 28, 2025

On April 21, 2025, Environmental Utilities, LLC filed a letter requesting an increase in its annual water system operating revenues. On April 25, 2025, the Staff of the Commission (Staff) filed a Small Utility Rate Case Timeline pursuant to the staff assisted rate case procedure under Commission Rule 20 CSR 4240-10.075. Subsection 6 of the rule requires a local public hearing to be scheduled to occur no later than 60 days after the opening of the case, unless all parties agree that a local public hearing is not necessary. In this case, that deadline is June 20, 2025.

The Commission will direct the parties to file a response recommending locations and dates for a local public hearing or that a local public hearing is not necessary.

THE COMMISSION ORDERS THAT:

1. No later than May 6, 2025, Staff shall consult with the parties in this case and shall file a joint response either listing recommended dates and locations for a local public hearing or notifying the Commission that a local public hearing is not necessary.
2. This order shall be effective when issued.
