ORDER RECOGNIZING NAME CHANGE

Issue Date: March 9, 2020

Effective Date: April 1, 2020

West Telecom Services, LLC submitted a letter dated February 27, 2020, advising that it has changed its name to Intrado Communications, LLC. The company has also filed an updated tariff to reflect the new name. That tariff carries an effective date of April 1, 2020. The Commission’s Staff filed a recommendation on March 9, 2020 indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of West Telecom Services, LLC, to Intrado Communications, LLC.
2. The revised tariff filed by Intrado Communications, LLC, (Tariff No. YL-2020-0143) will be allowed to take effect on April 1, 2020.
3. This order shall be effective on April 1, 2020.

4. This file shall be closed on April 2, 2020.
