ORDER DIRECTING RESPONSES TO REQUEST FOR CLARIFICATION

The Commission granted, with conditions, Union Electric Company d/b/a Ameren Missouri's application requesting expedited authority to issue and sell up to \$465,000,000 aggregate principal amount of additional long-term indebtedness. Ameren Missouri on March 13, 2020, filed a *Request for Clarification*, seeking to revise the effective date of the Commission's order in light of market conditions.

The Commission will direct Staff and the Office of Public Counsel to file a response to Ameren Missouri's request.

THE COMMISSION ORDERS THAT:

1. No later than 9 a.m. March 16, 2020, the Staff of the Missouri Public Service Commission shall file a recommendation regarding Union Electric Company d/b/a Ameren Missouri's *Request for Clarification*.
2. Any response by the Office of Public Counsel shall be filed no later than 9 a.m. March 16, 2020.
3. This order shall be effective when issued.
