

Legal Description of Proposed Route for the Grand Tower Crossing Project

COMMENCING AT THE EXISTING CITIZEN'S ELECTRIC WITTENBERG SUBSTATION LOCATED IN PART OF THE U.S. SURVEY 1244, TOWNSHIP 34 NORTH, RANGE 13 AND 14 EAST OF THE FIFTH PRINCIPAL MERIDIAN IN PERRY COUNTY IN THE STATE OF MISSOURI, TO A POINT OF DEFLECTION;

THENCE PROCEEDING IN A SOUTHEASTERLY DIRECTION PARALLEL WITH THE EXISTING CITIZEN'S ELECTRIC TRANSMISSION LINE THROUGH U.S. SURVEY 1244, TOWNSHIP 34 NORTH, RANGE 13 AND 14 EAST TO A POINT OF DEFLECTION, AND CONTINUING SOUTHEASTERLY THROUGH U.S. SURVEYS 1348 AND 2125, TOWNSHIP 34 NORTH, RANGE 14E OF THE FIFTH PRICIPAL MERIDIAN IN PERRY COUNTY IN THE STATE OF MISSOURI, TO A POINT OF DEFLECTION;

THENCE IN A SOUTHERLY DIRECTION THROUGH U.S. SURVEY 2125, TOWNSHIP 34 NORTH,
RANGE 14 EAST OF THE FIFTH PRINCIPAL MERIDIAN IN PERRY COUNTY IN THE STATE OF MISSOURI TO A
POINT OF DEFLECTION:

THENCE PROCEEDING IN A SOUTHEASTERLY DIRECTION THROUGH U.S. SURVEY 2125,
TOWNSHIP 34 NORTH, RANGE 14 EAST OF THE FIFTH PRINCIPAL MERIDIAN IN PERRY COUNTY IN THE STATE
OF MISSOURI OVER THE MISSISSIPPI RIVER AND INTO THE SOUTH ½ OF SECTION 14, SW ¼ OF SECTION 13
AND NW ¼ OF SECTION 24, ALL IN TOWNSHIP 10 SOUTH, RANGE 4 WEST OF THE THIRD PRINCIPAL
MERIDIAN IN JACKSON COUNTY IN THE STATE OF ILLINOIS, TO A POINT OF DEFLECTION;

THENCE PROCEEDING IN A NORTHLY DIRECTION THROUGH THE SW ¼ OF SECTION 13, TOWNSHIP 10 SOUTH, RANGE 4 WEST OF THE THIRD PRINCIPAL MERIDIAN IN JACKSON COUNTY IN THE STATE OF ILLINOIS, TO THE FUTURE JENKINS SUBSTATION PROPERTY LOCATED IN THE WEST ½ OF SECTION 13, TOWNSHIP 10 SOUTH, RANGE 4 WEST OF THE THIRD PRINCIPAL MERIDIAN IN JACKSON COUNTY IN THE STATE OF ILLINOIS, FOR THE POINT OF TERMINATION.

SAID CORRIDOR BEING APPROXIMATELY FOUR (4) MILES IN LENGTH AND ENCOMPASSING APPROXIMATELY EIGHTY (80) ACRES.
