ORDER DIRECTING RECOMMENDATION ON REVISED TARIFF

On April 30, 2025,¹ the Commission issued a *Report and Order Approving Territorial Agreement* in this matter. Among other things, that order directed The Empire District Electric Company d/b/a Liberty to submit revised tariff sheets to reflect the change in its certificated electric service area in Polk County resulting from the order.

On May 1, 2025, Liberty filed a tariff sheet, bearing an effective date of May 31, 2025, and assigned Tracking No. JE-2025-0149, purporting to comply with the terms of the Commission’s April 30th order.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted revised tariff sheet complies with the Commission’s April 30th order.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Liberty’s revised tariff sheet (Tracking No. JE-2025-0149) no later than May 15, 2025.
