On March 6, 2020, Elm Hills Utility Operating Company, Inc. filed a notice opening two staff assisted rate cases under Commission Rule 20 CSR 4240-10.075. The rule requires a local public hearing to be scheduled to occur within 60 days of the opening of the case. 60 days expires on May 5, 2020.

The Commission will direct the parties to file a response offering recommended locations and dates for local public hearings. The parties will include virtual meeting options to facilitate public involvement while preventing the spread of COVID-19 as directed for the purposes of public health.¹
