On January 21, 2020,¹ the Commission issued its Order Granting Convenience and Necessity. On January 29 and February 5, Missouri-American Water Company filed, respectively, Tariff Revisions YS-2020-0120 and JS-2020-0124. After the Commission's Staff recommended approval of the tariffs on February 10, the Commission issued a Notice and Order Regarding Compliance Tariffs on February 19, giving notice that the tariff sheets with tracking number YS-2020-0120 were approved to go into effect on February 28, and approving and ordering that the tariff sheets with tracking number JS-2020-0124 would go into on March 6. No further action is required, and this file may now be closed.

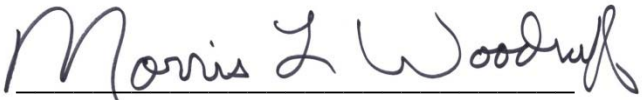
