The Commission opened this working case at the request of its Staff to gather information and facilitate discussion regarding the possible amendment of its rules related to cogeneration and net metering. After considering the comments of interested stakeholders, Staff has prepared draft rules and now asks the Commission to invite written comments responsive to those draft rules by June 15, 2018. Such comments are a continuation of the informal consideration of these rules. If the Commission decides to proceed with the formal rulemaking procedure required to promulgate these rules, the public will have another opportunity to comment during that procedure.
