## ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

Issue Date: May 2, 2025

Effective Date: May 2, 2025

On April 22, 2025,<sup>1</sup> Complainant Leah Gay Goessling filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. The same day, the Commission issued an *Order Giving Notice of Case Filing, Directing an Answer, and Directing a Staff Investigation*.

On May 1, Ameren Missouri filed a *Request for Mediation*, pursuant to Commission Rule 20 CSR 4240-2.125(2). Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate. If mediation is unsuccessful, the case returns to the contested case track. No party relinquishes any rights by agreeing to participate in mediation.

The Commission will order the complainant to respond and state if they agree to mediate the complaint.

1. No later than May 9, 2025, Leah Gay Goessling shall file a response to Ameren Missouri's mediation request and state whether she agrees to enter into mediation.
2. All other actions in this matter shall cease and all time limitations and deadlines are tolled until further order of the Commission.
3. This order is effective when issued.
