# SECOND ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE AN ANSWER

On April 3, 2025, Spire Missouri Inc., d/b/a Spire filed a motion requesting an extension to file an answer to Staff's complaint. Commission Rule 20 CSR 4240-2.070(8) requires Spire to file an answer within thirty days of the order giving notice of the complaint, unless the Commission orders otherwise. The Commission granted Spire an extension until May 5, 2025, to file an answer.

On April 30, 2025, Spire filed another request for an extension. In support of its request, Spire states that the parties are working on a stipulation and agreement to resolve some or all of the issues in this complaint.
