On May 1, 2025, Ameren Transmission Company of Illinois (ATXI) filed an application with the Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to Section 393.170, RSMo. The CCN would authorize ATXI to construct, install, own, operate, maintain, and otherwise control and manage an approximately four-mile 138 kV transmission line and associated facilities in Perry County, Missouri.

The Commission will provide notice of the application to the general public and interested parties, set a deadline for intervention requests, and direct the Staff of the Commission (Staff) to provide a recommendation regarding ATXI's application.

THE COMMISSION ORDERS THAT:

- 4. Staff shall file a recommendation regarding ATXI's application, or a request for additional time in which to file a recommendation, no later than July 31, 2025.
