On January 31, 2025, The Empire District Electric Company d/b/a Liberty filed an application with the Commission to initiate its Missouri Energy Efficiency Investment Act (MEEIA) Cycle 2. On April 10, 2025, Liberty filed a notice of dismissal with the Commission indicating that it was withdrawing its MEEIA Cycle 2. Liberty's withdrawal of the application also withdrew the accompanying proposed tariff sheets, Tracking No. JE-2025-0122.
