On May 2, 2025, Union Electric Company d/b/a Ameren Missouri filed tariff sheets, Tracking No. JE-2025-0150, to comply with the Commission's April 23, 2025, *Order Approving Stipulations and Agreements*, which resolved this general rate case. Those tariff sheets bear an effective date of June 1, 2025. In consideration of the parties' agreed June 1, 2025 effective date, the Commission will direct its Staff to file a recommendation expeditiously.
