NOTICE OF TRANSFER

COME NOW Cable One, Inc. ("Cable One") d/b/a/ Sparklight and Fidelity Cablevision, LLC ("Fidelity") d/b/a Sparklight ("Companies") pursuant to §67.2701 RSMo. and state to the Missouri Public Service Commission ("Commission") as follows for their notice of transfer of Video Service Authority.

1. On January 26, 2022, the Commission issued a Video Service Authority in File No. KA-2022-0188 granting expanded authority for Cable One to provide video services in additional political subdivisions.
2. For business purposes, Cable One and Fidelity have determined that it is in the Companies' best interests for Cable One to transfer certain Video Service Authority from Cable One to its affiliate Fidelity.
3. This transfer will be transparent to the Companies' customers as there will be no change in video service, and both Companies do business under the Sparklight name.
4. Therefore, the Companies hereby notify the Commission of the transfer of the Video Service Authority in the following political subdivisions from Cable One to Fidelity.
