ORDER SUSPENDING WORKSHOP

The Commission opened this working case at the request of the Office of Public Counsel to consider a rule regarding the reporting of residential customer disconnection data. The Commission scheduled a workshop meeting to be held on March 30, 2020, to discuss such a rule. On March 23, 2020, Public Counsel filed a motion asking that the workshop meeting be postponed due to the COVID-19 pandemic. Public Counsel asks that it and the Commission's Staff be directed to file a status report no later than April 15, 2020 regarding potential new dates for holding the workshop. The Commission will grant Public Counsel's request.

THE COMMISSION ORDERS THAT:

1. The workshop meeting scheduled for March 30, 2020, is suspended indefinitely.
2. The Commission's Staff and Public Counsel shall file a joint status report no later than April 15, 2020, regarding potential new dates for holding the workshop.
3. This order shall be effective when issued.
