SUPPLEMENTAL PROCEDURAL ORDER

On February 26, 2020, this case was set for an evidentiary hearing on April 1, 2020, commencing at 11:00 a.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. Because of the COVID-19 (or Corona) Virus, the Commission will order that the parties may participate in the hearing only by telephone and issue orders concerning affected procedural matters.

THE COMMISSION ORDERS THAT:

3. All exhibits shall be pre-filed with the Commission in EFIS. Ms. Stinnett's exhibits shall be numbered 1 through 100; Respondent's shall be numbered 101 through 200; and the Commission Staff's exhibits shall be numbered 201-300.

4. Ms. Stinnett may consult with the Commission Staff, who may assist her, in complying with this order.

5. To the extent not inconsistent with this order, all prior orders shall remain in full force and effect.

6. Objections to this order shall be filed no later than March 27, 2020.

7. This order shall be effective when issued.


