**RESPONSE TO COMMISSION ORDER**

Rebecca McGinley and McGinley-Krawczyk Farms, LLC, respond to the Commission's Order as follows:

1. On April 18, Rebecca McGinley filed an application to intervene.
2. On April 28, ATXI filed an opposition to the application.
3. On May 2, 2025, the Commission issued an order, stating:

Ms. McGinley is the sole member of McGinley-Krawczyk Farms, LLC and has representation. However, it is unclear whether the application to intervene was filed on behalf of Ms. McGinley, personally, or on behalf of her Limited Liability Company, and it is also unclear which entity is represented by counsel.

No later than May 9, 2025, the counsel who filed the McGinley-Krawczyk Farms, LLC application to file a supplement to the application to indicate whether the representation is of Rebecca McGinley in her individual capacity or of McGinley-Krawczyk Farms, LLC

4. Pursuant to the Commission's Order, the undersigned counsel clarifies that counsel represents both Rebecca McGinley and McGinley-

Krawczyk Farms, LLC and seeks intervention on behalf of both Ms. McGinley individually and McGinley-Krawczyk Farms, LLC.

**WHEREFORE**, Rebecca McGinley and McGinley-Krawczyk Farms respectfully request that the Commission issue an order granting their Application to Intervene and that McGinley and McGinley-Krawczyk Farms, LLC be made parties hereto with all rights to participate in this case.
