ORDER GRANTING EXTENSION REGARDING LOCAL PUBLIC HEARING

On April 28, 2025, the Commission issued an order directing Staff to consult with the other parties in this matter and file a list of recommended dates and locations for a local public hearing by May 6, 2025.

On May 6, 2025, the Staff of the Commission (Staff) filed a *Status Report and Motion for Extension*, stating that it had conferred with the Office of the Public Counsel, the two parties had agreed on dates for a local public hearing, and relayed those dates to Environmental Utilities, LLC, but the company has yet to respond. Staff, therefore, moves for additional time to file recommended dates and locations for a local public hearing.

The Commission will grant Staff's motion.

THE COMMISSION ORDERS THAT:

1. Staff's motion for extension is granted. No later than May 13, 2025, Staff shall consult with the parties in this case and shall file a joint response either listing recommended dates and locations for a local public hearing or notifying the Commission that a local public hearing is not necessary.

2. This order shall be effective when issued.
