## ORDER CANCELING REGISTRATION

Issue Date: May 2, 2025 Effective Date: June 1, 2025

On April 14, 2025, NEC Cloud Communications America, Inc. filed a letter seeking to cancel its registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted NEC Cloud Communications America, Inc. its IVoIP registration in the State of Missouri in File No. DA-2014-0197.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on NEC Cloud Communications America, Inc.'s request, the Commission finds that the IVoIP registration granted to NEC Cloud Communications America, Inc. shall be canceled.

- The registration to provide Interconnected Voice over Internet Protocol services, granted to NEC Cloud Communications America, Inc. in File Number DA-2014-0197, is canceled.
