Dear Judge Dippell:

Pursuant to 20 CSR 4240-28.011(2), Kingdom Telephone Company and Kingdom Telecommunications, Inc. (collectively, “Kingdom Companies”), respectfully request that the Missouri Public Service Commission (“Commission”) acknowledge their adoption of the Kingdom Networks fictitious name. The Kingdom Companies are in good standing with the Missouri Secretary of State, in compliance with the Commission’s Annual Report requirements, and current with their applicable Missouri USF and Commission assessments. The Kingdom Companies have reviewed their contacts on the Commission’s electronic filing and information system (EFIS), and they have been updated as needed.

Kingdom Telephone Company is an Eligible Telecommunications Carrier (ETC) and will continue to comply with all applicable laws and rules relating to the ETC designation. Also, please note that Kingdom Telephone Company was issued an IVoIP Registration in Case No. DA-2020-0347, and Kingdom Telecommunications Company was issued an IVoIP Registration in Case No. DA-2013-0463.

Evidence of the fictitious name registration of Kingdom Networks is included as Attachment A. A copy of the notice informing customers of the name change is included as Attachment B. A copy of the adoption notice and revised tariff title sheets that were filed concurrently with this notice reflecting the new name are included as Attachment C. Also, please note that Kingdom Telephone Company intends to withdraw PSC Mo. No. 3 (wireless termination tariff). PSC Mo. No. 3 has no customers.
