ORDER RECOGNIZING NAME CHANGE

West Safety Communications, Inc. submitted a letter dated March 13, 2020, advising that it has changed its name to Intrado Safety Communications. The company has also filed an updated tariff to reflect the new name. That tariff carries an effective date of April 12 2020. The Commission's Staff filed a recommendation on March 23, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of West Safety Communications, Inc. to Intrado Safety Communications Inc.
2. The revised tariff filed by Intrado Safety Communications, Inc, (Tariff No. YC-2020-0154) will be allowed to take effect on April 12, 2020.
3. This order shall be effective on April 12, 2020.
4. This file shall be closed on April 13, 2020.
