ORDER REGARDING APPLICATION

On March 23, 2020, Summit Natural Gas of Missouri, Inc. filed an application asking the Commission for a temporary variance from various rule and tariff provisions relating to late payment fees and service disconnection requirements. Summit makes that request in order to assist its customers who have been impacted by the COVID-19 pandemic. Summit asks that the waivers continue indefinitely until Summit determines that business has returned to normal or near normal conditions. Summit will provide at least fifteen-days' notice to customers before reinstating late fees and disconnection activities. Summit asks the Commission to approve its application as soon as possible.

Upon receiving Summit's application, the Commission directed its Staff and the Office of Public Counsel to respond. Both filed responses on March 24 expressing their non-opposition to the application.

The Commission will grant Summit's application.

Given the urgency of the situation, the Commission will make this order effective in two days.

THE COMMISSION ORDERS THAT:

1. Summit Natural Gas of Missouri, Inc.'s Application for a Temporary Variance from Rule and Tariff Provisions Relating to Late Payment Fees and Disconnection Rules is granted.
2. This order shall be effective on March 27, 2020.
