ORDER DIRECTING RESPONSES REGARDING DELAY OF TARIFF EFFECTIVE DATES DUE TO COVID-19 PANDEMIC

On August 29, 2019, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed notices opening two staff assisted rate cases under Commission Rule 20 CSR 4240-10.075. On February 10, 2020, the parties filed a *Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request.*On March 13, 2020, Confluence Rivers filed tariffs with an effective date of April 12, 2020.

The world is now experiencing a pandemic related to the spread of the COVID-19 virus. Because of the economic disruptions resulting from the pandemic, the Commission is concerned about an immediate increase in utility rates. For that reason, the Commission would like input from all parties on delaying implementation of Confluence Rivers' currently filed tariffs, YS-2020-0156 and YW-2020-0155. The Commission would specifically like to know if Confluence Rivers is willing to voluntarily extend the effective date of its filed tariffs for 90 days due to the ongoing impact of the COVID-19 pandemic.

Furthermore, the Commission will direct Confluence Rivers to identify what measures, if any, it is currently taking or will take to help customers facing disconnections due to lack of payment or late payment fees due to the economic impacts of COVID-19.

The Commission will direct all parties to respond.

THE COMMISSION ORDERS THAT:

- 1. No later than noon on April 3, 2020, all parties shall respond regarding a 90 day delay in implementation of the tariffs, YS-2020-0156 and YW-2020-0155, as discussed in the body of this order.
- 2. No later than noon on April 3, 2020, Confluence Rivers Utility Operating Company, Inc. shall provide the information as described in the body of this order.
 - 3. This order shall be effective when issued.
