## ORDER DIRECTING FILING

On May 12, 2025, Missouri-American Water Company (MAWC) filed revised tariff sheets designed to implement a general rate increase, as allowed by the Commission's *Report and Order* issued May 7, 2025. The tariff sheets bear an effective date of June 11, 2025, and have been assigned Tracking Numbers JW-2025-0157 and JS-2025-0158.

Also on May 12, 2025, MAWC filed a *Motion for Expedited Treatment and Approval of Compliance Tariffs* in which it asks the Commission to approve the tariff sheets to take effect on May 28, 2025, or as soon as thereafter as practicable.

The Commission will direct its Staff to file a recommendation on the revised tariff sheets and will set a deadline for other parties to respond.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation on the revised tariff sheets filed by MAWC and assigned Tracking Numbers JW-2025-0157 and JS-2025-0158 no later than 11:00 a.m. on May 16, 2025.
2. Any other party who wishes to file a response to MAWC's motion or Staff's recommendation shall do so no later than 1:00 p.m. on May 16, 2025.

3. This order shall be effective when issued.
