

ORDER DIRECTING RESPONSE


This case was opened for the purpose of receiving information, including a gas incident report, relating to a natural gas flash fire that occurred in an excavation in front of 1426 W. 50th Terrace, in Kansas City, Missouri, at approximately 4:25 p.m., Tuesday, August 8, 2000. On February 7, 2001, Staff filed its incident report. In the report, Staff recommends, *inter alia*, that Missouri Gas Energy, a division of Southern Union Company (MGE), be directed to file its response within 30 days. The Commission will order MGE to file a response to Staff's incident report.

IT IS THEREFORE ORDERED:

1. That Missouri Gas Energy, a division of Southern Union Company, shall file, no later than March 9, 2001, a response to the Gas Incident Report filed by the Staff of the Commission on February 7, 2001.

2. That this order shall become effective on February 24, 2001.
