ORDER APPROVING COMPLIANCE TARIFF SHEET

Issue Date: May 13, 2025

Effective Date: May 31, 2025

On April 30, 2025, the Commission issued a *Report and Order Approving Territorial Agreement* (Order) in this matter, effective May 10, 2025. Among other things, that order directed The Empire District Electric Company d/b/a Liberty to submit revised tariff sheets by May 15, 2025 to reflect the change in its certificated service area in Polk County resulting from the order.

On May 1, 2025, Liberty filed a revised tariff sheet, purporting to be in compliance with the Commission’s Order. That tariff sheet was assigned Tracking No. JE-2025-0149 and had a proposed effective date of May 31, 2025.

At the Commission’s request, on May 12, 2025, the Staff of the Commission reviewed Liberty’s tariff sheet and filed its recommendation that the Commission approve the tariff sheet. Upon reviewing the pleadings, the Commission finds Liberty’s proposed tariff sheet complies with the Commission’s Order and will approve it. To enable the tariff sheet to become effective on the date requested by Liberty, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on May 1, 2025, and assigned Tracking No. JE-2025-0149 is approved to become effective May 31, 2025. The approved tariff sheet is as follows:
