The evidentiary hearing in this matter is scheduled to be held May 29-30, 2025. This order assigns exhibit numbers and directs each party to file a list of its pre-filed, pre-marked exhibits. Exhibits shall be marked as set forth in Commission Rule 20 CSR 4240-2.135(10)(C); for example, "Exhibit 2" is public, whereas "Exhibit 2C" is the confidential version.

All parties shall bring an adequate number of physical copies of non-prefiled exhibits that they intend to offer into evidence at the hearing. If an exhibit has not been prefiled, the party offering it must bring copies for: the court reporter, the Commissioners, the presiding officer, and all counsel. Pre-filed exhibits do not require physical copies.
